

**1. purpose and Scope**

The house and bathing regulations apply to all guests of the Volksbad Limmer. It includes the fenced area of the bath as well as the car park.

The Volksbad Limmer is a sports center that is designed to provide maximum enjoyment and recreation for every visitor, regardless of religion, origin or age.

This rules ensure the security and order in Volksbad Limmer. By entering the parking lot and the bath or paying the entrance fee, each guest recognizes this house and bathing regulations.

**2. opening times**

The opening times of the Volksbad Limmer are determined by the management and can be seen on the homepage. The bathing time ends 15 minutes before operation shutdown. Last inlet is 30 minutes before operation shutdown.

The management may at all times restrict the offer of the Volksbad Limmer entirely or partly because of club training, sports events, disturbances, restorations or weather conditions.

Claims against the operator are therefore excluded.

**3. security**

For security reasons, individual areas are monitored by video. However, records are only viewed by management and handed over to the police.

The Volksbad Limmer assumes no liability for the loss of private valuables such as purse and mobile phones. It is therefore expressly pointed out that you will not have to bring along your valuables.

Every guest has to take into account the increased risk of accidents occurring in pools, which is due to wet ground surfaces, so every bathing guest should wear non-slip bath shoes outside the water. In addition, each guest is obligated to follow the instructions on the signposts and the instructions of the staff.

The approval of using water play devices such as balls, floats, etc., will be given by staff based on the frequency of visitors.

Persons who are suffering from a severe disability may only visit the Volksbad Limmer under the supervision of a full-time accompanying person. This also applies to guests with heart disease, epilepsy and powerlessness.

Non-swimmers and toddlers are generally to be supervised by a suitable supervisor. Use of the large swimming pool is prohibited. For minors, the responsibility generally lies with the legal guardians - **not** with the lifeguards or the staff.

Persons with infectious diseases and open wounds, as well as drunks and persons who are under the influence of intoxicating drugs, are not allowed to enter the bath.

Pets are not permitted.

The bringing of weapons of any kind is prohibited.

In case of disregard of the instructions of the staff or immoral behavior, the staff is taken to pronounce a house ban, if necessary also by adding the police. There is no refund of the entry fee.

The use of glasses or bottles in the pool area is prohibited.

**4. entrance and tickets**

The amount of the entry fees and the fixing of reductions are determined by the management. The definition is based on economic and social aspects.

The individual costs as well as reductions can be seen on the homepage and at the cashier's office.

Paid admissions will not be refunded

Change money is to be checked immediately, later complaints are not accepted.

10-card cards are valid only in the season in which they were purchased.

Each entry ticket is only valid on the day of the cancellation. When leaving the bath, the validity expires, re-entry is not possible. Tickets are not transferable.

**5. bathing and lingering**

By paying admission, there is no claim to a lie possibility or swimming lane.

With regard to other guests, loud screaming should be avoided.

Intimate acts will be punished with an immediate house ban - without refund of the entry fee.

Consumption of alcohol is only permitted to a reasonable extent. The staff of the Volksbad Limmer is entitled to prohibit the further consumption of alcohol and, in the case of inappropriate behavior, to declare a house ban - without refund of the entry fee.

**6. hygiene**

Every bather is obliged to clean himself before entering the pool.

Maliciously impurities e.g. of sanitary facilities will be charged to the bathing guest.

Shaving or dyeing hair is not permitted.

It is forbidden to urinate and ditch into the pool water on hedges or trees.

It is also forbidden to clean dishes, cutlery, clothing or other items in the bathing water

Waste must be disposed of in the designated waste bin.

**7. slides and toys**

The use of slides and toys is at your own risk.

Alcoholic guests are prohibited to use slides and toys.

Children up to 8 years must be supervised by a suitable person when using the slides. Follow the instructions on the signposts on the slide.

**8. smoking**

Smoking inside the buildings of the Volksbad Limmer is prohibited.

Smoking is allowed on the outside and outdoors, as long as other people are not disturbed by the smoke.

Cigarette stubs are to be dropped and thrown into the dustbin.

Smoking in the water and directly on the basin edge (splash water channel) is prohibited.

We reserve the right to impose a limited or complete ban on smoking at any time. This applies immediately. A verbal announcement or speech from our staff is sufficient.

**9. other provisions**

For the protection of privacy, photographing of other bathers is prohibited. Furthermore, it is forbidden to bring binoculars with you.

It is forbidden to distribute or display any kind of advertising medium such as flyers and posters, this also applies to the parking lot.

In addition, it is forbidden to collect money on your own behalf or for donation campaigns.

**10. liability**

Each guest is liable for damages, which he causes wantonly, abusive or even careless. This applies to the entire grounds of the Volksbad Limmer including the parking lots.

Parents are liable for damages caused by their children.

The Volksbad Limmer is liable for personal injury if the Volksbad Limmer is responsible for the damage - in general, no liability is assumed for property damage or theft. The Volksbad Limmer is not liable for the discoloration or damage of bathing clothes, watches or jewelry, since this may be a consequence of chlorine bound in the water. It is therefore recommended not to wear watches or jewelry when bathing.

The Volksbad Limmer is not liable for damage caused by force majeure or unforeseeable events (e.g. power failure, storms, etc.).

Lost items are kept for two weeks, valuables for two months. If these objects are not collected within the deadline, they will be disposed of in a professional manner.

No liability is assumed for damage, destruction or the loss of vehicles and bicycles on the parking lot.

**11. parking lot**

The parking lot in front of the swimming pool is the private grounds of the Volksbad Limmer and is publicly accessible.

The StVO is valid throughout the car park.

There is no winter service.

Parking is only allowed for the guests of the Volksbad Limmer, and only at regular opening hours.

It is forbidden to park vehicles of any kind outside the opening hours.

It is forbidden to drive with camper vans, trailers and caravans. It is also prohibited to spend the night.

Rescue trips, gates, escape and rescue routes are to be kept free. Vehicles which are illegally parked will be towed at a charge, and the wrong parking is reported at the police.

**12. final agreement**

The staff of the Volksbad Limmer is authorized to exercise the right of the house against all visitors.

The instructions of the staff are to be followed.

Guests who accessed illegally to the bath will be given a house ban and the incident will be brought to notice at the police.

**13. entry into force**

These house regulations will enter into force on May 9, 2024. Legally binding is the German version of this rules.
